ANNEX: Definition of IFRA Classes

| IFRA Class | Finished Product Types |

| Class 1.A | Toys; Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, lip wax etc) |
| Class 1.B | Waxes for mechanical hair removal |
| Class 2 | Deodorant and Antiperspirant products of all types (pump spray, aerosol spray, stick, roll-on, under-arm and body etc); Fragrance bracelets |
| Class 3.A | Hydroalcoholic products applied to recently shaved skin (EdT) |
| Class 3.B | Hydroalcoholic products applied to recently shaved skin (fine fragrance) |
| Class 3.C | Eye Products of all types (eye shadow, mascara, eyeliner, eye make-up, etc) including eye cream; Men's Facial Creams and Balms; Baby Creams, Lotions, Oils; Body paint for children |

| Class 11.B | All incidental skin contact, including: Pot pourri, fragrancing sachets, liquid refills for air fresheners (non-cartridge systems), Reed diffusers; Shoe polishes; Deodorizers/Maskers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders); Machine dishwash detergent and deodorizers; Odored Distilled Water (that can be added to steam irons); Scratch and sniff (sampling technology); Cat litter; Animal sprays (all types); Infused socks; Treated Textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles or fabrics, tights with moisturizers) |
