Section 2 - Composition

Sodium Alumino Sulphosilicate

Section 3 - Hazards Identification

This substance is not classified as hazardous.

Contact with acids could result in the liberation of hydrogen sulphide, a highly flammable toxic gas.

Section 4 - First Aid Measures

Skin Contact: Does not irritate the skin, wash off with soap and water.

Inhalation: Remove from area of exposure to fresh air. Seek medical attention in case of complaints.

Eye Contact: Rinse eyes with running water.

Ingestion: Non toxic no action needed. Seek medical attention in case of complaints.

Section 5 - Fire-Fighting Measures

Product itself is not flammable.

Toxic sulphur dioxide gas can be generated if this product undergoes chemical decomposition during a fire.

Extinguishing Media: Use extinguishing methods appropriate for surrounding fire.

Protective Equipment: Fire fighters should wear fully protective suits and self contained breathing apparatus.

Section 6 - Accidental Release Measures

No special precautions are necessary unless there is a chance of contact with acids in which case self contained breathing apparatus should be worn.

Wear suitable protective clothing and ensure adequate ventilation.

Methods For Cleaning Up: Keep the formation of dust to minimum levels.

Scoop, sweep or vacuum excess powder into a container for disposal.

Prevent seepage into water systems.

Section 7 - Handling And Storage

Precautions In Handling: Ensure good ventilation and avoid formation of excessive dust.

Storage Conditions: Store in a tightly closed container in a cool dry room and avoid all contact with acids.

Contact with acids could result in the liberation of hydrogen sulphide, a highly flammable toxic gas.

Section 8 - Exposure Controls / Personal Protection

Dust mask should be worn if the dust concentration is more than 10 mg/m³. Use in a well ventilated area to control dust exposure to applicable limits.

Clothing: Use an apron or protective overalls to avoid staining of clothing.

Form: Powder.

Colour: Violet.

Odour: Odourless.

Flammability: Product is not flammable.
